**Note-B:** The abovementioned waitlisted candidates in “**LIST-B (Waitlisted Candidates under above-**

The offer of provisional admission, if any, would be made to the candidates mentioned in “**LIST-B**” in order of their merit (i.e. CLAT Rank/Score) and such candidate will have to deposit the entire amount of fees and submit the relevant certificates/documents specified in the “**Instructions and Schedule for Completion of Admission Formalities for the UG and PG Candidates allotted to HNLU (Posted on 1<sup>st</sup> July 2019)**” and complete the admission formalities on **29<sup>th</sup> July 2019** itself. Therefore, the waitlisted candidates mentioned in “**LIST-B**” are essentially required to come prepared and report in person to the University **from 02:00 pm to 03:00 pm on 29<sup>th</sup> July 2019** so that they can complete the admission formalities, in case the offer of admission is made to him/her. **In case the abovementioned waitlisted candidates fail to report on scheduled date and time with all the stipulated documents and fee etc., they will also forfeit their offer of admission made to them and the seat will be offered to the next waitlisted candidates.**

**Important Notes:**

1. Provisional admission to the selected candidates would be offered only after verifying the original certificates/documents and satisfying all eligibility conditions.
2. The candidates who fail to complete the admission formalities by submitting the requisite fees and the required certificates/documents specified in the “**Instructions and Schedule for Completion of Admission Formalities for UG and PG Candidates allotted to HNLU**” on the date of admission will forfeit the offer of admission made to them.
