They have confirmed minutes subject to the observations made with regard to payment to Shri S.C. Deshpande.

Decision:

The Executive Council decided that information may be collected from other National Law Universities regarding status of implementation of recommendations of Sixth Pay Commission and UGC for Universities and colleges. The matter may be placed before the Finance Committee of the University at the first instance.

6. Discussion and decision regarding furnishing of University buildings.

Decision:

The Executive Council constituted a committee comprising of Vice-Chancellor, Secretary Finance Department, Secretary Law Department and Secretary Higher Education for finalization of different offers received from different companies. If needed more proposals may also be called.

7. Discussion and decision regarding payment of R.A. Bill No.16 (Revised) of NCCL,
& Discussion and decision regarding construction work.

Decision:

The Executive Council has shown deep concern in regard to completion of HNLU Building Project hence constituted a Committee of Vice-Chancellor HNLU, Advocate General Chhattisgarh, Principal Secretary P.W.D., Secretary Law Department, Secretary Finance Department and Secretary Higher Education Department Govt. of C.G. to convene a meeting with NCCL officials to discuss and decide all issues related to construction of HNLU buildings. The Committee is requested to submit a report within two weeks

The Executive Council appreciates the services rendered by Shri Deshpande and hopes and trusts that the same shall be available as and when required. The Committee constituted by the Executive Council may, if any necessity arises, consult Shri Deshpande.

9. Discussion regarding continuance/discontinuance of Shri S.C. Deshpande.

Decision:

The Executive Council approves the appointment of Shri D.K. Pradhan as University Engineer-in-Charge keeping in view the fact that Shri Deshpande is not in a position to make day to day supervision.

The Executive Council decided as under:

- (a) Request should be made to the State Government to relax the reservation norms for filling the reserved posts which were advertised but suitable candidates were not available, where posts remained vacant for more than one year.
- (b) Meanwhile contractual appointments should be made for one year against reserved posts, subject to the condition that as and when sufficient number of candidates in this category are available, appointments shall be made as per the reservation policy of the State.

1. Perusal and approval of budget for the Financial Year 2009-2010

Proceedings:

The Finance Committee perused and discussed the proposed budget for the Financial Year 2009-2010. The Finance Committee also perused and discussed the budgets and the audited income and expenditure of the F.Y. 2007-08 and discussed the income and expenditure of the F.Y. 2008-09. The Finance Committee appreciated that the University's financial status is gradually improving and we are moving towards self-sufficiency.

Decision:


The Finance Committee perused, discussed and approved the budget for the F.Y. 2009-2010.

2. To discuss and make recommendations on the issue of implementation of recommendations of the Sixth Pay Commission and UGC at HNLU

Proceedings:

The Finance Committee was apprised that in the meeting held on 31st January, 2009 by the Hon'ble Chief Justice of India, decision has been taken that "the request be made to the appropriate authorities for providing salary structure and faculty positions on the lines of the professional colleges such as I.I.T.s and I.I.M.s."

The committee was also apprised that being recognized u/s. 2(f) of the UGC Act, 1956 it is mandatory for the University to follow the instructions issued by UGC. UGC vide letter no. F.1-6/2009/PRC dated February, 2009 has directed the University that scheme of revision of pay and payment should be made as per Government of India, Ministry of HRD, Department of Higher Education, New Delhi letter No.1-32/2006. U.II/U.I(i) dated 31.12.2008 and that the fitment table for fixation of pay is likely to be received shortly and hence payment should be made after

taking an undertaking from the beneficiary to the effect that any excess payment made on account of incorrect fixation of pay in the pay band or academic grade pay shall be adjusted against the future payments due.

The committee also noted that in the recent past some teaching staff has left institution to join other employers for higher pay and perks. Since the recommendations of Sixth Pay Commission have already been adopted for Central Government and State Government employees and their respective Universities/institutions, it is felt appropriate in the light of directions of the University Grants Commission that the pay scales as well as allowances proposed vide UGC letter no. F.1-6/2009/PRC dated February, 2009 be implemented in this University w.e.f. the date mentioned in the letter no.1-32/2006-U.II/U.I(i) dated 31st December, 2008.

Decision:

The Finance Committee after deliberations recommended for consideration of the Executive Council that the recommendations of the Sixth Pay Commission notified vide GOI notification dated 29th August 2008 and directions issued by UGC vide letter No. F.1-6/2009/PRC dated February, 2009 with regard to GOI order No.1-32/2006.U.II/U.I(i) dated 31.12.2008 may be adopted at HNLU. The Committee also recommended for payment of 40% of the arrears during this financial year (2008-2009) and balance in the next financial year 2009-2010; after deducting applicable income tax and taking the required undertaking as directed by UGC in its letter no. F.1-6/2009-PRC dated February, 2009 for teaching and non-teaching employees of HNLU.

The Committee also recommended that those employees, who are not on payroll of the University as on date, may be paid only after the final notification of UGC.

The Committee recommended that in future Hon'ble Executive Council may consider adoption of revised pay scales of IITs and IIMs as per the decision taken by Hon'ble Chief Justice of India in the meeting held on 31st January, 2009.

Sub.: Scheme of revision of pay of (a) teachers and equivalent cadres and (b) administrative posts in universities and colleges following the revision of pay scales of Central Government Employees on the recommendations of the Sixth Central Pay Commission.

Sir/ Madam,

The Commission has received orders from the Government of India, Ministry of Human Resource Development, Department of Higher Education, New Delhi vide letter No. 1-32/2006-U.II/U.I(i) and 1-32/2006-U.II/U.I(ii) dated 31st December, 2008 on the above subject and to say that the State Government may take action to adopt the above Government of India scheme for State Universities and Colleges and payment of pay scales, enhancement of retirement age and release of 40% of the arrears during the current financial year in accordance with these provisions. The Commission is in the process of finalizing Regulations in consultation with the stakeholders.

The fitment tables for fixation of salary is likely to be received from the Central Government shortly which will be circulated to all State Governments and Universities and will also be placed on UGC website. The payment may be made taking an undertaking from every beneficiary under the scheme to the effect that any excess payment made on account of incorrect fixation of pay in the pay band or academic grade pay shall be adjusted against the future payments due.


The State Governments may initiate immediate action so that the implementation of this scheme may be in a time bound manner.

**REPORT OF THE COMMITTEE CONSTITUTED BY THE EXECUTIVE
COUNCIL**

Dt.03.03.2009

The committee consisting of Vice Chancellor, HNLU, Advocate General, Chhattisgarh, Principal Secretary (PWD), Secretary (Law), Principal Secretary (Higher Education), and Secretary (Finance), Government of Chhattisgarh has convened its meetings on 12th January and 21st February, 2009.


The committee has gone through all the details, assessed the progress of construction work and discussed on the issues with M/s. NCCL.

The findings of the committee are as under:

- a. The committee has found that the attitude of the construction company M/s. NCCL has been entirely negative and blunt. They have slowed down the pace of the work and stopped the work since last one and half years, and six months respectively.
- b. They have made so many promises to complete the project but never complied. They have delayed the project and charged escalation.
- c. The company has submitted bills even for the work not performed; such amount was deducted by the Engineering Staff of HNLU from the bills. A number of constructions were found defective and no rectification was made even after giving them notice. They are claiming payment for extra-items without proper permission or order of University authorities.
- d. It is difficult to believe that M/s. NCCL is willing to work or will be able to complete the project.

Based on the above facts, the committee is forced to recommend as under:

1. The University may terminate the contract within the norms of the contract agreement.
2. The University may take over executed/unexecuted construction work to give it to any other construction agency at the risk and cost of NCCL as per the terms of contract agreement.





OPINION REGARDING THE PROPOSAL RECEIVED FROM FIRST UNIVERSITY ENGINEER-IN-CHARGE AND THE CLAIM OF SHRI S.C. DESHPANDE.

Shri Ashok Kumar Dubey, Reader, Government Engineering College Raipur was engaged as Project Management Consultant/University Engineer-in-Charge of the building project through Government Engineering College/N.I.T. Raipur by the first Vice Chancellor of HNLU Prof. Jose P. Verghese. The terms of payment and scope of work was narrated vide letter No.849 stating that Government Engineering College/National Institute of Technology Raipur has been extending its services in preparing tender forms/notices etc., monitoring the project and providing consultancy services for this project charging proportionate fee @0.5%. This charge is inclusive of appointment of a team of Engineers and supervisory staff for maintaining the quality control during the construction, hiring a vehicle for a period of 14 months for the use of their staff and to perform the task of University Engineer-in-Charge as required in the contract of HNLU building project.

Shri S.C. Deshpande of Sewri Consultants, Mumbai is demanding proportionate fee @1% merely for checking and authentication of bills once they are processed by the technical staff of the University. Apart from this he is being paid extra charges for airfare, stay arrangements, hospitality, conveyance for self and Engineers coming alongwith.

In comparison to the charges claimed by the first University Engineer-in-Charge/ Project Management Consultant, the charges claimed by Shri S.C. Deshpande, Sewri Consultants Mumbai seem to be exorbitant.

Assessing the overall situation it is recommended that Shri S.C. Deshpande should be paid on any of the following basis:

1. Proportionate Fee @0.5% of the bills he has passed after deducting the amount already paid to him for airfare, stay arrangements, hospitality, conveyance etc.
2. Proportionate Fee @0.25% of the bill he has passed, since University has already made payments towards airfare, stay arrangements, hospitality, conveyance etc. It is important to mention that NIT/first University Engineer-in-Charge/P.M.C. had appointed technical staff & hired vehicle for supervision but during the tenure of Shri S.C. Deshpande, the University has appointed and paying for supervisory staff such as Executive Engineer (Elect.), Asst. Engineer (Civil), Sub Engineer (Elect.) and other Field Supervisors.
3. Payment that the Executive Council may deem fit.
