COUNCIL TO PREPARE ANNUAL REPORTS


The fifteenth meeting of the Executive Council of Hidayatullah National Law University took place on 05.04.2008 at 9.00 a.m.

The fifteenth meeting of the Executive Council of Hidayatullah National Law University took place on 05.04.2008 at 9.00 a.m.


