

**Notification Inviting Applications from Candidates belonging to Dependants of Freedom Fighters (DFF) and Specially Abled Persons (SAP) for Admission to the B. A. LL. B. (Hons.) Program under CG Domicile DFF and SAP Category**


Date: 5<sup>th</sup> August 2019

The admission to the B. A. LL. B. (Hons.) Program under the C. G. Domicile reserved category seats such as SC, ST and OBC and the horizontal reservation covering Women, DFF, SAP, etc. is done according to the Chhattisgarh Educational Institutions (Reservation in Admission) Act, 2012 and the provisions contained therein. Accordingly, the admission to various horizontally reserved category candidates are offered following the percentage of seats specified by the Guidelines issued by the State Government from time to time and the same was provided in the CLAT-2019 Brochure.


However, as per the latest guidelines issued on 24<sup>th</sup> May 2019 by the Directorate of Higher Education, Government of Chhattisgarh, for the Academic Session 2019-20, it has been specified that 3% seats are to be reserved for the DFF and 5% seats for the SAP category candidates. Since the CLAT 2019 Brochure was printed much before the guidelines were issued by the Government and the same came to the knowledge of the University on 24<sup>th</sup> July 2019, the required number of seats could not be allotted by the CLAT Secretariat.

Therefore, in view of the above guidelines issued by the Government of Chhattisgarh on 24<sup>th</sup> May 2019 for reserving 3% and 5% seats for DFF and SAP candidates, respectively, the university seeks to fill-up the remaining seats by inviting applications from the respective categories of candidates who have appeared in CLAT 2019 under the abovementioned categories. The interested candidates may therefore apply in the prescribed Application Form latest by 05:00 p.m. of 8<sup>th</sup> August 2019. The duly filled-in Application Form complete in all respect must be submitted through e-mail ([admission@hnl.u.ac.in](mailto:admission@hnl.u.ac.in)) on or before the scheduled date and time specified above.

**Note:** *Incomplete applications and applications received after the last date shall not be considered. The University authorities shall not be responsible for the delay, if any.*
