

Notification for Foreign National Candidates for Admission to the B. A. LL. B. (Hons.) Program (Academic Session 2019-20)

Date: 25th April 2019

As specified in the CLAT-2019 Information Brochure, the Hidayatullah National Law University, Atal Nagar, seeks to invite applications from eligible Foreign Nationals for filling up the **four seats** under the Foreign National Category.

Eligibility:

To be eligible for admission to the five-year integrated B. A. LL. B. (Hons.) Program under the Foreign National Category, the applicants should necessarily be Foreign Nationals and should have passed the Senior Secondary School/Intermediate (10+2) or its equivalent Examination from India or from abroad from the recognized board/university of that country with not less than 45% marks in aggregate.

Candidates who are appearing or have appeared in the qualifying examination (10+2 or its equivalent) and are awaiting results are also eligible to apply and take admission subject to the condition that such candidates must have passed the qualifying examination with the required percentage of marks at the time of admission and must be able to submit proofs in support of their claims.

Interested eligible Foreign Nationals seeking admission under the Foreign National Category Seats may apply in the prescribed Application Form with the copies of the following certificates/documents:

- (a) Copy of the Valid Passport
- (b) Copy of the Birth Certificate in proof of age
- (c) Copy of the Statement of Marks obtained in the Qualifying Examination, i.e. Senior Secondary School/Intermediate (10+2) or its equivalent
- (d) Copy of Conversion Certificate issued by the competent authority stating the percentage of marks equivalent of the grades obtained, in case the Statement of Marks is issued in terms of Grades.
- (e) Application Fee of Rs. 6,000/- payable through electronic transfer only as per the Bank Account details given below. The receipt/proof of payment made through electronic transfer (i.e. UTR No./Transaction ID, etc.) must be enclosed/attached along with the Application Form.

3. Apart from the above, the foreign national students will be required to fulfill other formalities and submit the required undertakings/application forms as may be applicable to other students.
