

**Notification for Admission to the B. A. LL. B. (Hons.)/LL.M. Program under
Supernumerary Quota for the Wards of Kashmiri Migrants
(Academic Session 2019-20)**

Date: 18th June 2019

As per the Circular/Directives issued by the University Grants Commission (UGC) as well as Ministry of Human Resources Development (MHRD), Government of India, Hidayatullah National Law University (HNLU), Naya Raipur, has **five seats** reserved for the Wards of Kashmiri Migrants for admission to the B.A.LL.B. (Hons.) Program. Similarly, **two seats** are reserved for the Wards of Kashmiri Migrants for admission to the LL.M. program offered by the University. Interested eligible candidates belonging to the abovementioned category (i.e. those who have applied for and appeared in the CLAT-2019 under the Kashmiri Migrants Category), may directly apply to the University in the prescribed Application Form with the copies of the following certificates/documents:


- (a) Copy of the Birth Certificates
- (b) Copy of current Residential Certificate
- (c) Copy of Certificate issued by Competent Authority in support of claim for being the Ward of Kashmiri Migrants
- (d) Copy of the Statement of Marks obtained in the Qualifying Examination, i.e. Senior Secondary School/Intermediate (10+2) or its equivalent along with conversion certificate in case of grade system
- (e) Copy of Statement of Marks obtained in the Qualifying Examination, i.e. B.A.LL.B., LL.B./B.L., or any other equivalent degree from a recognized university with not less than 55% marks in aggregate in case of Post-Graduate Candidates.

The scanned copy of the filled-in application form along with the digital (scanned) copies of required documents must be sent/submitted electronically to admission@hnlu.ac.in with a copy marked to the Registrar (registrar@hnlu.ac.in) **latest by 05:00 p.m. of 28th June 2019** with the application fee of **Rs. 1,000/-** payable through electronic transfer only as per the Bank Account details given below. The receipt/proof of payment made through electronic transfer (i.e. UTR No./Transaction ID, etc.) must be enclosed/attached along with the Application Form.
