In order to complete the admission formalities, the candidates selected above are required to send the scanned copy of following certificates/documents saved into a single PDF file in the same serial order at admission@hnlu.ac.in on or before 5:00 p.m. of 19th October 2020.

2. Mark Sheet of 12th Examination or its equivalent
3. Transfer Certificate
4. Migration Certificate
5. Character Certificate
6. CLAT-2020 Admit Card
7. Copy of Money Transfer Certificate/Receipt to HNLU Bank A/C along with Conversion Certificate
8. Proof of Nationality (Copy of valid Passport of NRI/OCI Candidate or NRI/OCI Relative Sponsoring the Candidate)
9. Certified Copy of Passport/OCI Card (Photostat copy of the Passport/OCI Card certified by Indian Embassy or Indian Consulate of the Country where the NRI/OCI is residing)
10. Declaration by the NRI/OCI Sponsoring a Candidate as per format given in Annexure - 1/1A)
11. NRI/OCI Certificate (Certificate from Indian Embassy or Indian Consulate of the country where the NRI/OCI is residing as per the format given in Annexure - 2/2A & 3/3A)
