2. Mark Sheet of 12<sup>th</sup> Examination or its equivalent.
3. Mark Statement of LL.B. or B.L. of equivalent degree.
4. Transfer/Migration Certificate.
5. Character Certificate.
6. CLAT-2020 Admit Card.
7. Copy of Money Transfer Certificate/Receipt to HNLU Bank A/C.
8. Copy of current Residential Certificate.

The certificate/document mentioned in Sl. No. 8 is essential in nature and the admission under the above category is being offered on that basis. Hence, it is mandatory for candidates to submit the certificate on or before the time and date specified failing which the candidates shall forfeit the offer of admission made to them.
