Certificates/Documents required to be submitted for Completing Admission:

In order to complete the admission formalities, the candidate selected above is required to send the scanned copy of following certificates/documents saved into a single PDF file in the same serial order at admission@hnl.ac.in on or before 5:00p.m. of 22nd October 2020.

1. Mark Sheet of 10th Examination.
2. Mark Sheet of 12th Examination or its equivalent.
3. Mark Statement of LL.B. or B.L. of equivalent degree.
4. Transfer/Migration Certificate.
5. Character Certificate.
6. CLAT-2020 Admit Card.
7. Copy of Money Transfer Certificate/Receipt to HNLU Bank A/C.
8. Copy of current Residential Certificate.

The certificates/documents mentioned in Sl. No. 6 to 8 are essential in nature and the admission under the above category is being offered on that basis. Hence, it is mandatory for candidates to submit these certificates/documents on or before the time and date specified failing which the candidates shall forfeit the offer of admission made to them. However, the candidates lacking in other documents may be allowed to complete the admission formalities by submitting an undertaking to that effect.

Important Notes:

1. Provisional admission to the selected candidates would be offered only after verifying the certificates/documents and satisfying all eligibility conditions.
2. The candidates who fail to complete the admission formalities as mentioned above on the date of admission shall forfeit the offer of admission made to them.
