

**Notification Inviting Applications for Admission to the B. A. LL. B. (Hons.) and LL. M. Program

After the completion of the admission process on 6<sup>th</sup> July 2016 of the Fourth and Final List of Candidates allotted to HNLU by CLAT-2016, HNLU has certain vacant seats for admission to the B.A.LL.B.(Hons.) and LL.M. Program under various categories of seats as given under:

The university seeks to fill-up these vacancies by inviting applications from the respective categories of candidates who have appeared in CLAT 2016. The interested candidates may therefore apply in the prescribed Application Form **latest by 05:00 p.m. of 12<sup>th</sup> July 2016** along with the Application Fee of Rs. 1000/- payable either through Demand Draft (Drawn in favour of Registrar, HNLU, Raipur, payable at Raipur) or through National Electronic Fund Transfer (NEFT) as per the Bank Account details given below. The receipt/proof of payment made through electronic transfer (i.e. UTR No./Transaction ID) must be enclosed/attached along with the Application Form.

The duly filled-in Application Form complete in all respect and accompanied with a Demand Draft of Rs. 1000/-towards Application Fee (**drawn in favour of Registrar, HNLU, Raipur, payable at Raipur**) must be sent/submitted through **registered/speed post only**, so as to reach the **Registrar, Hidayatullah National Law University, Post-Uparwara, Abhanpur, Naya Raipur-492 002 (Chhattisgarh)**, **latest by 05:00 p.m. of 12<sup>th</sup> July 2016**.

Alternatively, the scanned copy of the filled-in application form along with the digital (scanned) copies of required documents can also be submitted electronically through email to: [admission@hnl.ac.in](mailto:admission@hnl.ac.in) with a copy marked to: [registrar@hnl.ac.in](mailto:registrar@hnl.ac.in) on or before the scheduled date and time specified above.

The list of valid applications received by the date and time specified above will be processed and published on the University website on **14<sup>th</sup> July 2016** and the selected candidates will be required to complete the admission formalities by personally reporting to the University with the required certificates/documents and fees **on 18<sup>th</sup> July 2016**. ***In case of failure to complete the admission formalities on 18<sup>th</sup> July 2016, the selected candidates will forfeit the provisional admission offered to them.*** The waitlisted candidates will be considered for admission only when the candidates selected for provisional admission do not take admission by depositing the fees and certificates/documents by the date and time specified above. The offer of provisional admission, if any, would be made to them in order of their merit (i.e. CLAT Rank) and **such waitlisted candidates will have to deposit the fees and complete the admission formalities on or before 22<sup>nd</sup> July 2016**.

The candidates interested in applying for admission under two different categories of seats will have to submit two separate applications and for doing the same, the candidates will have to pay the application fees twice by making two separate National Electronic Fund Transfers (NEFT). It is essential to be noted that any attempt to fill in and submit separate application forms online by furnishing the same NEFT-UTR No. will not be accepted by the system.

*Note : As the Hidayatullah National Law University is located 30 kms away from the main city of Raipur and the courier services are not up to the mark, the candidates are strongly advised not to send their applications through courier.*

*Incomplete applications and applications received after the last date shall not be considered. The university authorities shall not be responsible for the postal delay, if any.*
