

**Notification Inviting Applications for Admission to the B. A. LL. B. (Hons.) and LL. M. Program

After the completion of the admission process on 30th June 2018 of the Third and Final List of Candidates allotted to HNLU by CLAT-2018, HNLU has certain vacant seats for admission to the B.A.LL.B.(Hons.) and LL.M. Program under various categories of seats as given under:

**In CLAT-2018 brochure, it has already been mentioned that the allotment of seats under various CG Domicile Category will be made as per the Guidelines issued by the Government of Chhattisgarh from time to time. The Directorate of Higher Education, Government of Chhattisgarh has issued guiding principles regarding admission for the academic session 2018-19 in Chhattisgarh Govt/ Semi Govt. Colleges. In the light of above the university has reserved 5% seats for Specially Abled Persons (SAP) and 3% seats for the Dependents of Freedom Fighters (DFF) candidates of Chhattisgarh domicile. One seat thereof has already been filled by the DFF candidate against the seats reserved for them, therefore as of now, one seat for DFF and four seats for SAP candidates, which are horizontally reserved, lie vacant in the abovementioned category.*

The university seeks to fill-up these vacancies by inviting applications from the respective categories of candidates who have appeared in CLAT-2018. The interested candidates may therefore apply in the prescribed Application Form **latest by 05:00 p.m. of 07th July 2018** along with the Application Fee of Rs. 1000/- payable through National Electronic Fund Transfer (NEFT) only as per the Bank Account details given below. The receipt/proof of payment made through electronic transfer (i.e. UTR No./Transaction ID) must be enclosed/attached along with the Application Form.

The duly filled-in Application Form complete in all respect and accompanied with the receipt/proof of payment must be submitted electronically through email to: admission@hnl.ac.in on or before the scheduled date and time specified above.

The list of valid applications received by the date and time specified above will be processed and published on the University website on **11th July 2018** and the selected candidates will be required to complete the admission




formalities by personally reporting to the University with the required certificates/documents and fees on **17th July 2018**. *In case of failure to complete the admission formalities on 17th July 2018, the selected candidates will forfeit the provisional admission offered to them.* The waitlisted candidates will be considered for admission only when the candidates selected for provisional admission do not take admission by depositing the fees and certificates/documents by the date and time specified above. The offer of provisional admission, if any, would be made to them in order of their merit (i.e. CLAT Rank) and **such waitlisted candidates will have to deposit the fees and complete the admission formalities on or before 24th July 2018**.

Note : Incomplete applications and applications received after the last date shall not be considered. The university authorities shall not be responsible for delay, if any.
